Waivers:

1. Barking Pals Consulting, Inc. DBA Allegiance Canine ("Allegiance Canine") will endeavor to create as safe an environment as possible for the training and boarding care of the dog(s) identified above (the "Dog"), and will offer only sound, safe, and responsible training, care, and post-boarding or post-training instructions. While Allegiance Canine will make every reasonable effort to help Owner achieve training and behavior modification goals, Allegiance Canine makes no guarantee of Dog's performance or behavior as a result of providing professional animal behavior consultation. Owner agrees, furthermore, that all animals may exhibit unpredictable behaviors and that Allegiance Canine will not be liable for the actions of the Dog that are outside of the control of Allegiance Canine. Owner agrees that the recommendation by Allegiance Canine of any product or service is not a guarantee of performance or Owner's satisfaction with that product or service. Owner understands that he/she and members of the household must follow Allegiance Canine's instructions without modification, work with the dog daily as recommended, and constantly reinforce training begin given to Dog.
2. Allegiance Canine agrees to indemnify and hold Owner harmless from and against any claims of injury, expense, costs, loss or damages caused by the gross negligence or willful misconduct of Allegiance Canine while the Dog is in the sole custody, care and control of Allegiance Canine. Owner acknowledges that Allegiance Canine has no control over the Dog when the Dog is not in the exclusive custody, care and control of Allegiance Canine, and Owner agrees to indemnify and hold Allegiance Canine harmless from and against any and all claims of injury, expense, costs, loss or damages caused by the actions of the Dog when the Dog is not in the sole custody, care and control of Allegiance Canine.
3. Owner agrees to indemnify and hold Allegiance Canine and Allegiance Canine's agents harmless from and against any claims of injury, illness, or loss of life while the Dog is in the sole custody, care and control of Allegiance Canine. Owner acknowledges that Allegiance Canine may only be held liable for injury, illness or loss of life if willful negligence by Allegiance Canine can be proven or determined by a neutral, agreed-upon, licensed veterinarian.
 - a. Willful negligence includes: loss or theft of Dog, illness or death of Dog if determined by a neutral, agreed-upon, licensed veterinarian to be caused from willful negligence, injury from a dog fight, abuse of training equipment or sickness from feeding the wrong food.
 - b. Willful negligence does not include: illness or death caused by genetic composition or act of nature, or allergies (Food or Environmental.)
 - c. If actions of Allegiance Canine are deemed to be willfully negligent by a neutral, agreed-upon, licensed veterinarian, reparations include:

- i. In case of injury of Dog: veterinary costs and refund of half of all training or service costs.
 - ii. In case of loss or theft of Dog: fair market value of Dog (determined by purchase price, age, health, breed and pedigree) and refund of full training or service costs.
 - iii. In case of death of Dog: fair market value of Dog (determined by purchase price, age, health, breed and pedigree) and refund of full training or service costs.
4. Owner acknowledges that transitional changes (defined as lack of appetite leading to weight loss, temporary attitude changes, or temporary change in behavior) do not constitute negligence or willful negligence, and agrees to indemnify and hold Allegiance Canine and Allegiance Canine's agents harmless from and against any claims of injury, expense, costs, loss or damages caused by transitional changes.
5. If Dog causes property damage, or bites or injures any dog, animal, or person [including but not limited to Allegiance Canine and Allegiance Canine's agents], during or after the term of this Agreement, then Owner agrees to pay all resulting losses and damages suffered or incurred, and to defend and indemnify Allegiance Canine and Allegiance Canine's agents from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees. If Dog is injured in a fight or in any other manner during or after the term of the Agreement, Owner assumes the risk and agrees that Allegiance Canine should not be held responsible for any resulting injuries, losses, damages, costs or expenses.
6. Owner acknowledges and agrees that owning any animal, including the Dog, has inherent risks, including but not limited to the risk of dog bites to Owner.
7. At Allegiance Canine's sole election, Allegiance Canine's duties hereunder shall terminate if (a) in Allegiance Canine's sole judgement Dog is dangerous or vicious to Allegiance Canine or any other person or animal, or interferes with the training of other dogs, or (b) Owner breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, Allegiance Canine's duties shall terminate but all other provisions of this Agreement shall continue in full force and effect.
8. Owner fully understands the tools and techniques that are used to train and modify the behavior of their dog and agrees to the tools and techniques which include Prong Collar, Bark Collar, Remote Training (E-) Collar, Slip Lead, Muzzles, Flat Buckle Collar.
